To better serve our members, your Board of Directors is pleased to announce the following options for paying your Amarillo Club bill:

- 1) By Mail: You may continue to pay your bill by issuing a check and returning it with your statement stub in the envelope provided. Please mail in time to reach us by the due date which is the 20th of each month. Do not send cash.
2) In Person: You may bring your payment to the accounting office: Chase Tower, 15th floor, Suite 1500. Drop it through the mail slot by the door or deliver it to accounting personnel if present.
3) By Electronic Check: You may complete the attached form and use your checking, business checking, or savings account to make a one-time payment or authorize Amarillo Club to debit your bank account automatically each month for the balance of your Amarillo Club account. You may return the completed and signed form along with your Amarillo Club statement stub in the envelope provided or fax both to the Accounting office at 806-373-4334.
4) By Credit Card: You may complete the attached form and use your Visa, MasterCard, Discover or American Express to make a one-time payment or authorize Amarillo Club to debit your credit card automatically each month for the balance of your Amarillo Club account. You may return the completed and signed form along with your Amarillo Club statement stub in the envelope provided or fax both to the Accounting office at 806-373-4334.

We trust these payment options will add convenience to the payment of your Amarillo Club account each month. If you would like to pay by electronic check or credit card, please complete the attached form and return it along with your Amarillo Club statement stub in the envelope provided, or fax both to the Accounting office at 806-373-4334. Because we must have your written authorization, we cannot accept payments over the phone. Thank you.
